Legal

Joe said that he sent a contract to Fitness Lifestyles, but has not received a signed copy as of yet. Joe advised the Board not to pay Fitness Lifestyles until all of the equipment has been delivered.

Chief's Report

Chief Jason Howlett gave his incident report for the month of July, 2011. Chief Howlett told the Board that 19-2-78 was involved in two separate accidents on the evening of July 29, 2011. The truck is currently out of service and waiting on the insurance company. Chief Howlett said that the Holmdel Board of Education has donated an old school bus for an extrication drill. Jason handed over the Title to the Clerk until the Fire Company is finished with the extrication drill. The Chief's also handed out a set of Fitness Room Rules for the Board to look over.

The Chief's said that they are still having problems with the pager system. Many different ways were discussed on how to fix the problem. One way is to install a Parrot Repeater System, which would rebroadcast the tone and message after a short delay. Howell Township is looking for a new radio repair company and will ask them to look into the problem that we are having.

Committees

Frank gave a report on the Executive Board meeting, which was held on July 28, 2011.

Frank gave a report on the trucks as follows,

- 1) 19-2-90 is back in service and Frank will set up the reinspection.
- 2) The New Chief's Command Vehicle will be registered this week and is going to New Jersey Emergency Vehicles on August 16, 2011 for the conversion.
- 3) The Insurance Company told Frank to order the windshield and the mirror parts for 19-2-78 in order that we can drive it to the repair shop.
- 4) Bob Tice's Chief's car was repaired at Pine Belt.
- 5) The annual pump tests are scheduled for August 8, 2011.

Old Business

George said that E. J. Schuster's would be at the Route 33 Fire Station tomorrow to repair the chair in the Radio Room. George also said that the Alarm System seems to working at the Route 33 Fire Station. George said that the current N. J. American Water bill is correct. They are charging us for the proper amount of hydrants. They will be installing the new Fire Hydrant at 133 Yellowbrook Road next week.

We received a letter from Campbell Supply Company requesting 19-2-75 in Wildwood for the week of September 12, 2011. The Board told the Chief's that this would depend on the condition of 19-2-78. If 2-78 is back in service by that time, then Campbell can have 2-75.

Frank said that it was time for the annual inspection of the Vehicle Exhaust System at the Route 524 Fire Station. Clean Air said that the cost would be \$716.00, unless they find something which needs repairing or replacing. A resolution was offered by Harry Carter, and seconded by George Patten, to award the annual inspection to Clean Air for \$716.00. A roll call vote was taken.
