We received a statement, from the New Jersey Motor Vehicle Services, for all abstract look ups completed in October 2013. We received an Affidavit of Publication, from the Asbury Park Press, for the publishing of our Budget Hearing. We received a check, from the Township of Howell, which is our forth fire taxes payment. The Check, in the amount of \$437,500.00, was received and deposited on November 21, 2013.

Chief's Report

Chief Brian Prochnow read his incident report for the month of November 2013. Chief Prochnow asked to purchase the following items.

- 1) One pair of turnout pants from Safe-T, on N. J. State Contract #80948, for a total of \$1,346.61.
- 2) Repair and install Drag Rescue Harnesses in eleven turnout jackets from Safe-T for a total of \$2,324.80.
- 3) One Cairns 1010 white helmet and four helmet frontals from Continental Fire and Safety, on N. J. State Contract #80953, for a total of \$598.76.
- 4) Ten replacement impact caps (helmet shells) from Continental Fire and Safety, on N. J. State Contract #80953, for a total of \$997.30.
- 5) Twelve self-retracting tag lines for the search rope bags from AAA Emergency Supply, for a total of \$1,980.00.
- 6) Fifteen Majestic Pac II nomex hoods from Emergency Equipment Sales for a total of \$479.25.
- 7) Annual fit testing for breathing air masks from CNP Fittest of New Jersey for \$25.00 each and \$15.00 for any Firefighter that has a second mask.

- 1) We received the pump test reports from Fire One. All trucks passed.
- 2) 19-2-96 is scheduled to be serviced and repaired before the end on the month by Defender Emergency Products.
 - 3) 19-2-93 was repaired at Bargs Lawn and Garden Shop.
 - 4) 19-2-90 is having some running issues and will be picked up by Absolute tomorrow.
 - 5) We started the repairs on 19-2-76.
- 6) The compressor for the Vehicle Exhaust System at the Route 524 Fire Station has stopped working. Frank called Clean Air to come and repair. Frank also purchased an air hose and some fittings and tied the system into the engine bay compressor for now.

George said that the Boiler Inspector came on November 20, 2013 and we passed. George also said that both Emergency Generators were serviced on November 14, 2013. George said that he and Frank had toured around Equestra and approved some more Fire Hydrants to be added to the bill. George said that N. J. American Water has asked if we would approve the installation of eight New Fire Hydrants on Route 524. These would then be added to our monthly Fire Hydrant Bill.
