Legal

The regular meeting agenda was altered so that the Board could hold the Public Hearing of the proposed 2019 Fire District Budget.

A motion was made by Tom Ward and seconded by Frank Biddle III, to open the Public Hearing for the proposed 2019 Fire District Budget. Motion passed.

Joe asked if we had received the Budget back from the State. Frank said no, but did say that we received an email stating that the Budget was approved and we could hold the Public Hearing. Joe read over the 2019 Fire District Budget that was sent to the State.

Joe read a resolution, Adopting the 2019 Howell Township Fire District #2 Budget as follows.

Joe said that this concluded the Budget Hearing. A motion was made by Tom Ward and seconded by Doug Howlett, to close to Public Hearing. Motion passed.

Chairman Carter asked Joe to finish his legal portion of the meeting at this time.

Joe read a letter that he was asked to write and send to Equestra about the Fire Hydrants that are located in their development. Joe said that he sent the letter on November 21, 2018

Joe said that petitions for the office of Fire Commissioner need to be handed into the Fire District Clerk no later than January 20, 2019.

Communications

We also received several e-mails from the State Division of Pensions, which will be on file. We received an Affidavit of Publication, from the Asbury Park Press, for the publication of the 2019 Fire District Budget Public Hearing. We received a check, from the Township of Howell, which is our finale payment of the 2018 Fire District taxes. The check, in the amount of \$343,750.00, was received and deposited on November 30, 2018. We received a second check, from Glatfelter Claims Management, which is for the replacement of the Motorola Portable Radio that disappeared. The check, in the amount of \$7,198.00, was received and deposited on November 23, 2018. We received a third check, from Glatfelter Claims Management, for the repair of 19-2-88 after striking a deer. The check, in the amount of \$1,304.47, was received and deposited on December 1, 2018.

We received several communications, from Liberty Mutual Insurance, concerning a resent injury to a Firefighter at a mutual aid structure fire. We received am email, from the New Jersey State DCA, advising us that our introduced 2019 Fire District Budget has been approved. The email stated that we could proceed with our adoption. The email was dated November 29, 2018, and we still have not received the approved 2019 Fire District Budget. We received two Service Reports, from EMR Power System, for the two service checks completed on our two Emergency Generators on November 13, 2018. We received four Fire Pump Performance Test Reports, from Fire One, for the annual pump tests on four of our Fire Apparatus.

Chief's Report

Chief Michael Whitehill gave his incident report for the month of November 2018. The Chief would like to purchase the following items.

- 1) Twenty Five (25) pair of Pro-Tech 8 Fusion Firefighting Gloves from Continental Fire & Safety, on State Contract #80956, for a total of \$1,552.75.
- 2) Construct a concrete apron around the outside of the Training Prop at the Route 33 Fire Station, with JPS Masonry, for a total of \$17,375.00. Three quotes were asked for and this is the lowest that meets the specs.

After some discussion, a resolution was offered by Frank Biddle III and seconded by Tom Ward, to grant the two purchase requests. A roll call vote was taken.

Chief Whitehill brought up the issue with the dispatching with Howell Township. Lots of discussion was had on this subject and the future. The Chief asked the Board to put funds in the 2020 Fire District Budget to help fund a study as what would be the best fix for the system.

First Assistant Chief Player said that the Board of Fire Commissioners is not doing enough for the Fire District and the Howell Township Fire Company Number One. He seemed to challenge the Board. The Board listened to Chief Player for quite a while. The Board took no action after Chief Player was finished.

Committees

Tom gave a report on the Executive Board meeting which was held on November 15, 2018.

Frank gave a report on the trucks and equipment as follows.

- 1) Campbell Supply completed a recall on 19-2-75 on November 13, 2018. The recall was to replace the engine fan.
 - 2) 19-2-88 was serviced at Jiffy Lube.
- 3) Frank took 19-2-66's vehicle to Lester Glenn of Freehold to get a recall completed on November 14, 2018.
 - 4) Frank replaced the headlight switch and pigtail on 19-2-93.
 - 5) Frank replaced the oil dip stick on 19-2-88.

- 6) The New Gas Meter came in from Electronic Measurement Laboratories.
- 7) Michael replaced the batteries on 19-2-67's vehicle.
- 8) 19-2-90 came back from repairs at Absolute on November 15, 2018.
- 9) Frank replaced the right side wiper arm on 19-2-85.
- 10) Tom took 19-2-98 and 19-2-99 to Jiffy Lube for service.
- 11) Having some starting issues with 19-2-68's vehicle. Will change the batteries next week.
- 12) 19-2-88 struck a deer on November 27, 2018. Glatfelter Claims Management approved the repair at Branning Collision of Freehold. The truck was dropped off last night.
 - 13) 19-2-85 will be going to Campbell Supply for warranty work at the end of the week.
- 14) 19-2-75 had a no start issue on November 19, 2018. Campbell replaced the transmission control unit and the truck was back in service on November 29, 2018.
 - 15) The Pump Test for 19-2-90 is scheduled for January 2, 2019.
 - 16) Still waiting on UL for a date to retest 19-2-90.
- 17) One door lock at the Route 524 Fire Station is broken. Frank swapped it out with one from a seldom used door for now. We could use some parts and a couple new locks.

Old Business

We received a new quote from ABG Electric to move the parking lot pole and light in the rear lot of the Route 33 Fire Station. The quote is for \$6,100.00. After some discussion, a resolution was offered by Harry Carter and seconded by Doug Howlett, approving the work to be completed by ABG Electric. A roll call vote was taken.
