REGULAR MEETING

Notice of time, date, location and agenda of the meeting, to the extent then known, was duly published in accordance with the requirements of the "Open Public Meeting Act' at least 48 hours in advance of this meeting by posting and by publication in the official newspapers of the district.

The meeting was called to order by Chairman Harry Carter, at 8:00 PM.

A Roll call was taken showing George Patten, Frank Biddle III, Harry Carter, Thomas Ward, and Doug Howlett present. Also in attendance was Joseph Youssouf, Board Attorney. The Chairman then led all in attendance with the Pledge of Allegiance.

A motion was made by Doug Howlett and seconded by Tom Ward; to approve the minutes of the last meeting held on January 7, 2019, motion carried.

We received the approved LOSAP cost of living adjustment for 2018. The approved LOSAP increase is 0.49% with a maximum award of \$1,717.00. Communications

We also received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received information, from the Monmouth County Superintendent of Elections, about picking up all the election paperwork and the delivery of the Voting Machine. We received an Affidavit, from the Asbury Park Press, stating who the Operations Director is and what their circulation was for the period between October 1, 2017 and September 30, 2018. We received a report, from the Insurance Services Office (ISO), following their visit of last year.

We received a report, from Complete Security Systems, for the Annual Fire Alarm & Detection Equipment inspection for the 925 Adelphia Road Fire Station. An email was sent to Bob Lewis, of the Howell Township Fire Bureau, letting him know that we decided to not let Howell Township use the Route 33 Fire Station as a voting place.

We received an email, from the New Jersey Department of Community Affairs, that included the Annual LOSAP cost of living adjustment. The approved Fire District adjustment for 2018 is 0.49% with a maximum LOSAP award of \$1,717.00. See the resolution that was adopted earlier in this meeting.

Legal

Joe gave a report on the upcoming Election and Budget Vote. Joe said that we still do not know how many Absentee Ballots need to be sent out. As on this meeting, it looks like around 775. He reminded Frank that the paperwork needs to be picked up on Friday, February 15, 2019 and that the Voting Machine will be delivered sometime on Thursday, February 14, 2019.

Joe said that the County will be paying for the Absentee Ballots this year, but we will have to pay after that. Joe also suggested that we print up some Provisional Ballots for anyone that shows up that received an Absentee Ballot and wants to vote. It was decided to have Joe get 50 Provisional Ballots made up.

Chief's Report

Second Assistant Chief Dan Roth gave his incident report for the month of January 2019. The Chief asked if they could schedule the annual flow tests of the SCBA Packs with the local authorized dealer, Firefighter One, for a total of \$2,107.00. After some discussion, a resolution was offered by Harry Carter and seconded by Doug Howlett, to allow the Chief to schedule the annual testing with Firefighter One. A roll call vote was taken.

Committees

Tom gave a report on the Executive Board Meeting, which was held on January 24, 2019.

Frank gave a report on the trucks and equipment as follows.

- 1) 19-2-85 was dropped off at Campbell Supply on January 22 for the repair of the cascade system. The truck was picked up the following day after repairs were completed. They said to keep an eye on the cascade system for any leaks. This work might end the warranty period on this truck.
- 2) The check engine light came on in 19-2-66's vehicle. We dropped it off at Lester Glenn of Freehold on January 13, 2019. Along with some other items we asked them to work on, they replaced the engine oil pump on warranty. The check engine light came back on the next week, but went off the same day. We will keep an eye on it.
 - 3) We replaced both batteries on 19-2-88 on January 23, 2019.
 - 4) We replaced both fog lights and the fuse that powers them on 19-2-88.
 - 5) We replaced the trailer plug on 19-2-93 with a RV Style.
- 6) 19-2-90 struck a deer while responding to a call on January 25, 2019. No damage was noticed on the truck.
- 7) We replaced two carburetors on two of the three water pumps. We will be replacing the third one after we get some more parts.
- 8) We purchased new belts and pulleys for 19-2-88. The parts will be installed in the next few weeks.
 - 9) Graga Construction serviced the Station Air Compressor at the Route 33 Fire Station.
 - 10) We are working on remounting the shore air connection on the side of 19-2-75.
- 11) Frank reprogrammed the door locks at both Fire Stations. While doing this, the battery in the program Lap Top went dead two times. We will be looking to replace that battery soon.
- 12) Clean Air was called to repair the Vehicle Exhaust Systems at both Stations. They should be here this week sometime.

13) The Emergency Generator at the Route 524 Fire Station on January 31, 2019 during a power outage with very cold conditions. This is the second time in about a year that this generator failed to start when needed.

Old Business

George said that we still have not received an invoice from the Boiler Inspection that was completed last month.

New Business

Firefighter and Ex-Chief Robert Tice asked the Board if they ever created a resolution supporting the Junior Firefighter Program that the Fire Company runs. George said that he thought that they did many years ago, but would probably not be able to find it. After some discussion, Joe was asked to draw up a resolution supporting the Junior Firefighter Program for the March meeting.

With no further business to come before the Board, the meeting was adjourned at 9:18 PM.
