We received a service and repair report, from Continental Fire and Safety, for work completed on our Breathing Air Compressor. This work was completed on January 7, 2013. We received a notice, from Chevrolet, about a possible problem with our 2009 Chief's vehicle. Frank said that he would keep an eye on this vehicle to see if the problem exists. We received the Affidavit of Publication, from the Asbury Park Press, for the publication of our Notice of Budget Adoption and Annual Referendum. This advertisement was published in the January 10, 2013 Asbury Park Press. We received a statement, from AmeriGas, stating that our account balance is \$0.00. Since we have switched the Route 33 Fire Station over to natural gas, we are no longer using propane.

Legal

Joe said that we are all prepared for the upcoming election on February 16, 2013. The voting machine has been ordered and Frank was reminded to pick up the keys and the voter registration lists on Friday, February 15, 2013 by 4:30 PM.

Joe gave a report on a phone conversation he had with Mr. Brasslow, concerning the Township's proposed ordinance that would take back financial control of the Howell Township Fire Bureau. The Joint Board of Fire Commissioners has been in control of the Howell Township Fire Bureau for many years after being asked to do so by the Township of Howell. Joe read a letter from Mr. Gannon addressed to Mrs. McKenna Kingdon, of the Township of Howell. Joe also read a letter

from Mr. Sendzik addressed to Mr. Gannon. Joe gave to Board his opinion of these letters and the proposed new Township of Howell ordinance.

Chief's Report

Chief Brian Prochnow gave his incident report for the month of January 2013. Chief Prochnow said that he is in the process of obtaining prices to replace the search rope bag on 19-2-85. The bag is damaged and most likely unable to be repaired. After a brief discussion, a resolution was offered by Doug Howlett and seconded by Tom Ward, allowing the Chief to purchase a new search rope bag from the vendor with the lowest price. Committees

Frank gave a report from the Executive Board meeting which was held on January 24, 2013. Frank said that Chief Hotmar gave out all the 2012 Site Plan Reviews to each District. Chief Hotmar also gave out the Howell Township Fire Bureau's 2012 yearly report. Frank also gave a report on the trucks and other items as listed below.

- 1) 19-2-78 went up to Absolute for repairs and came back on January 30, 2013. The major repair was to the right rear cab mount, which had snapped all the mounting bolts for the second time.
- 2) The bay door at the Route 33 Fire Station in front of 19-2-74 has been acting up. Frank installed some missing hardware, but the door still needs some work. Frank called Nolze Garage Door on February 2, 2013 to come and repair. Nolze Garage Door came and repaired the door on February 4, 2013.
- 3) The light tower on 19-2-85 is still drifting down during operation. Frank e-mailed Wil-Burt and is still waiting for a return e-mail. Frank went over some choices for repair. Frank said that the Wil-Burt authorized repair vendor, in our area, is Campbell Supply. Frank will ask Campbell Supply to give us a price to repair the light tower.
- 4) Frank said that he mounted the two grinders at the two Fire Stations.
- 5) Frank has received prices, after being asked by the Chief, for the needed tools on 19-2-90. These prices also include safety items for the two Grinders and an electrical test meter for the Route 33 Fire Station. These items will be coming from Grainger and Snap-On Industrial. All prices are on State Contract.

A resolution was offered by Tom Ward and seconded by George Patten, to purchase the items from Grainger and Snap-On Industrial as requested by the Chief and Engineer. A roll call vote was taken.
