Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a Loss Run, from Liberty Mutual, for any claims against our Workers Compensation policy. We received an Annual Reconciliation of Tax Withheld form, from the New Jersey Division of

Taxation, which is filed annually for us by Paychex. We received a letter, from New Jersey American Water, stating that they are changing the billing cycles again.

We received a notice, from the New Jersey Motor Vehicle Commission, stating that some customers were receiving fictitious emails with invoices attached. They said to disregard any of these emails and that they would always send out invoices by mail. We also received our statement, from the New Jersey Motor Vehicle Services, for all abstract retrievals completed in November 2018.

We received a check, from Glatfelter Claims Management, for additional damages to 19-2-88 from the deer strike. The check, in the amount of \$294.46, was received and deposited on December 13, 2018. We received a Holiday Season card from Access Health Systems. We received a Life Hazard Use Certificate of Registration, from the New Jersey Department of Community Affairs Bureau of Fire Code Enforcement, for the Training Room at the Route 33 Fire Station. This Certificate will be posted at the Route 33 Fire Station.

Legal

Joe went over the dates that the State of New Jersey sets for the 2019 Fire District Budget Schedule. As of this meeting, the State has yet to return our approved and adopted 2019 Budget. Joe also talked about the 2020 Fire District Budget changes. Joe went over the dates and times for the 2019 Fire District Election. The date for this year's Elections is February 16 from 2:00 PM to 9:00 PM. The last date for filing a petition for the office of Fire Commissioner is January 21, 2019. Frank said that two Commissioners are up for re-election, Harry R. Carter and Thomas P. Ward. Frank said that he would call Joe with the names on the petitions sometime on January 21, 2019.

Frank asked Joe about a Temporary Budget to get us through until our March meeting or until our 2019 Budget is passed by the Voters. Joe said that the Temporary Budget would be 14% of the operating portion of the 2018 Fire District Budget. After some calculations, Joe said that the Temporary Budget would be \$137,057.20. A resolution was offered by Frank Biddle III and seconded by Tom Ward, creating a Temporary Budget of \$137,057.20 to carry us from January 1, 2019 to March 4, 2019 pending Voter approval of the 2019 Fire District Budget. A roll call vote was taken.

Chief's Report

First Assistant Chief Greg Player gave his incident report for the month of December 2018 and also the yearend report for 2018. The Chief asked if they could purchase a few items. The Board said that unless it is an emergency purchase, they would rather wait until the 2019 Budget is passed by the voters to make any purchases.

The Chief asked about records storage and how long they needed to keep some records. Joe said that all records need to be kept forever. They could be stored electronically and kept that way in order to save space, but that would take a lot of time to convert things over.

The Chief asked about other ways of recruiting Firefighters. The Fire Company is talking about adding an Active Associate class to the current bylaws. This new class might be limited to around five people. The Chief asked about insurance and LOSAP for this new class if it is passed by the Fire Company. The total process, if started sometime this year, would not take effect until 2020 or later. The Board said that they would get some information from the Insurance Company the next time they are in contact with them.

Ex-Chief Bob Tice asked the Board about the future of the Fire Company Junior Program. As of now, there are no Juniors in the program. The Fire Company wants to continue with the program, but is revamping the requirements. They will be requiring all Juniors to get a physical before they would be allowed to participate in the program. This physical would only count during the time that they would be a Junior. They would need another Physical when they become age 18 and join the Fire Company. After some discussion, a resolution was offered by George Patten and seconded by Harry Carter, to provide physicals for all Juniors. A roll call vote was taken.

Ex-Chief George Gravatt Jr. asked the Board if they could have an Insurance Company Representative come to one of the Fire Company meetings. The members have some questions about what is not covered in the Boards Insurance Policies. George Patten said that he would ask about someone attending a Fire Company meeting.

Chief Player told the Board that the December Harassment Training was good and that they will try to schedule this class each year. Chief Player said that they are looking for a more extensive class for Fire Company Officers and even Fire Commissioners.

Second Assistant Chief Dan Roth told the Board that the Monmouth County Fire Academy is looking for some used equipment. Chief Roth said that he would make a list of the items that they are looking for, check our availability, and come back with what items we have. As of now, they are looking for about ten to fifteen old SCBA Masks.

Committees

Due to the Holidays, there was no E-Board meeting in December.

Frank gave a report on the trucks as follows.

- 1) We replaced the batteries on 19-2-68's vehicle.
- 2) Brannings finished the repairs on 19-2-88 after the deer strike.
- 3) 19-2-85 went to Campbell Supply on December 7th for warranty work. The Truck came back on January 4, 2019, but is not completed.
 - 4) 19-2-90 passed the Annual Pump Test on January 2, 2019.
 - 5) Still waiting on a date from UL for the retest of 19-2-90.
 - 6) Both 19-2-67 and 19-2-68 had their vehicles serviced at Jiffy Lube.
 - 7) Edward Tire Company replaced another tire pressure sensor on 19-2-68's vehicle.

Old Business

George said that the Boiler at the Route 33 Fire Station was inspected and passed.

New Business

We received a request, from the Township of Howell, for the use of the Route 33 Fire Station as a voting facility starting in 2019. Lots of discussion was had on the security issues that we would face during the full day of voting. When all was said and done, a motion was made by Harry Carter and seconded by George Patten, to turn down the Township of Howell's request. Motion passed.

Frank said that we need replace the air card in 19-2-85's computer with one that is installed internally. We would need to call Verizon and cancel the current one and add the new one to our contract. Frank said that he thought that this would not cost anything additional. After some discussion, a resolution was offered by Harry Carter and seconded by Doug Howlett, to get the needed air card from Verizon and cancel the current one. A roll call vote was taken,
