Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a check, from the Township of Howell, for the 2nd 2014 Budget payment. The check, in the amount of \$315,000.00, was received and deposited on July 1, 2014. We received a letter, from New Jersey American Water, stating that they will be installing approximately 9,000 feet of new 16" water mains. These new lines will be along Wyckoff Mills Road, Adelphia Farmingdale Road, Howell Road, Patterson Drive and Vanderveer Road. The project will include 8 new fire hydrants and will start about July 7, 2014. We received a letter, from Freehold Cartage, stating that they will be changing their billing dates to the first of the month. This change resulted in a double payment this month. We received the Affidavit of Publication, from the Asbury Park Press, for the publication of our Budget Synopsis for the year ended December 31, 2013.

We received our new Radio Station License, from the Federal Communication Commission, for our KRI-761 Radio Station. The expiration date for this license is July 6, 2024. The original was mounted is the frame in the Radio Room. We received the May 2014 statement, from the New Jersey Motor Vehicle Services, for all abstract retrievals completed in May.

Legal

Joe read over a report, from the New Jersey State Comptroller, about Fire District Budgets and Spending. The State Comptroller recommends moving the Fire District Elections to November. He also recommends keeping the 2% cap in place. This report was dated June 16, 2014.
