## **REGULAR MEETING**

Notice of time, date, location and agenda of the meeting, to the extent then known, was duly published in accordance with the requirements of the "Open Public Meeting Act' at least 48 hours in advance of this meeting by posting and by publication in the official newspapers of the district.

The meeting was called to order by Chairman Harry Carter, at 8:00 PM.

A Roll call was taken showing George Patten, Frank Biddle, III, Harry Carter, Thomas Ward, and Doug Howlett present. Also in attendance was Joseph Youssouf, Board Attorney. The Chairman then led all in attendance with the Pledge of Allegiance.

A motion was made by Tom Ward and seconded by George Patten; to approve the minutes of the last meeting held on June 1, 2015, motion carried.

A discussion was had on the payment for the New Rescue Pumper. Spartan ERV said that if we pay for the truck in full, up front, that the cost would be \$785,727.00. This would be a savings of \$14,246.00 over the original cost of \$799,973.00. It would take more than ten years to make that much money in interest. A resolution was offered by Frank Biddle III and seconded by George Patten, to pay for the New Rescue Pumper up front in full to take advantage of the savings. A roll call vote was taken.

## **Communications**

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a statement, from New Jersey Motor Vehicles, for all abstract retrievals completed in May of 2015. We received a check, from the Township of Howell, which is the second payment of our 2015 Fire Taxes. The check, in the amount of \$247,500.00, was received and deposited on July 3, 2015.

We received a check, from Glatfelter Insurance Group, which is a refund for cancelling the insurance on the 2004 Chevrolet Suburban Command Vehicle. The check, in the amount of \$81.73, was received and deposited on June 13, 2015. We received an order confirmation, from HGACBuy, for the ordering of the New Rescue Pumper. We received an e-mail, from Grantmasters, stating that they would be happy to work with us. We received confirmation that we completed our IROC for the State Pension System.

# Legal

Joe read the resolution Authorizing the Purchase of One New Custom Built Rescue Pumper. Some corrections needed to be made and Joe will bring the resolution back in August. Joe gave a report on a Bill in the State that seems to gaining support. This Bill would allow Fire Districts to consolidate within their town.

# **Chief's Report**

After looking over the three quotes, the Board asked the Chiefs to draw up a spec for the vendors to quote on. The three quotes received were all for three different systems.

## **Committees**

Frank gave a report on the Executive Board Meeting, which was held on June 25, 2015. Frank also gave a report on the trucks as follows.

- 1) First Priority replaced the rotted fuel tank on 19-2-78.
- 2) Johnson & Towers 19-2-78. This repair included the replacement of the turbo.
- 3) Chief 2-66 had his vehicle serviced at Jiffylube on July 1, 2015.
- 4) Clean Air repaired the Exhaust System at the Route 33 Fire Station.
- 5) East Coast Emergency Lighting replaced the strobe lights on 19-2-78. The new light package consists of all LED lights.
  - 6) 19-2-66's vehicle was towed to the Front End Shop on July 5, 2015.
- 7) The Front End Shop said that the fuel pump was not working and the vehicle would be completed on July 7, 2015.
  - 8) The Survivor Light Chargers came in at Jersey Coast Fire Equipment.

## **Old Business**

Tom said that All Fenced In will be coming out to repair the dumpster enclosure at the Route 33 Fire Station.

## **New Business**

George said that two members have left the Company and he will drop the Life Insurance for these two people. George also said that one of these members was not vested in the LOSAP program and he would call for the funds to be returned.

Frank said that he installed the last flag on the flagpole at the Route 33 Fire Station. Frank said that we need to purchase some more flags and some repair parts for the flagpole.
