We received our Summary of Audit Report, from Robert A. Hulsart and Company, for the year ended December 31, 2015. We received a request for a tax exempt certificate from G & L Lawn Service. George sent out a letter of exemption on July 5, 2016. We received a check, from the Township of Howell, which is payment #2 of the 2016 Fire Taxes. The check, in the amount of \$247,500.00, was received and deposited on July 5, 2016. We received a statement, from the State of New Jersey Motor Vehicle Services, for all abstract retrievals requested during May, 2016.

## **Chief's Report**

Chief Michael Banasz gave his incident report for the month of June, 2016. Chief Banasz would like to purchase a variety of hand and cordless power tools from Fastenal for the New Rescue Pumper. Total for the requested tools would be \$2,394.77, and all are on State Contract #A79873. A resolution was offered by Tom Ward and seconded by Doug Howlett, to purchase these tools from Fastenal. ## **Committees**

Frank gave a report on the Executive Board meeting, which was held on June 23, 2016.

Frank also gave a report on the trucks and other equipment as follows.

- 1) 19-2-78 is back in service after a lengthy repair for a pump shift issue. The repairs were completed at Absolute Fire Protection.
- 2) 19-2-67 had his vehicle serviced at Jiffy Lube.
- 3) One of the ventilation saws, off of 19-2-90, was repaired at Barg's Lawn and Garden Shop.
- 4) Art is working to repair the Officer's seat on 19-2-75.
- 5) Defender Emergency Products was asked to quote some additional needed repairs on 19-2-96. The quote for the repairs to the pump is \$4,045.73. If approved, Frank would like to truck serviced at the same time. The service would be an additional cost.
- 6) The truck committee when out to look at the New Rescue Pumper in June. The truck is coming along very well and the final inspection trip should be in early August.
- 7) We will be needing a new Knox Box for the New Rescue Pumper. This purchase would be around \$800.00 and is from the sole source of the Knox Company.
- 8) We will also be needing a new Laptop for the New Rescue Pumper. The current Rescue Truck, 19-2-85, does not have one. The cost for this addition would be \$4,207.00 from Island Tech Services. This is the same company that installed the Laptop in 19-2-78. State of New Jersey Contract MO483-89974.

After some discussion, a resolution was offered by Tom Ward and seconded by Doug Howlett, to have Defender Emergency Products repair and service 19-2-96, order a new Knox Box for the New Rescue Pumper and order the new Laptop for the New Rescue Pumper from Island Tech Services.
