We received both our Annual Financial Report and Annual LOSAP Report, from Robert A. Hulsart & Company, for the year ended December 31, 2018. We received a check, from the Township of Howell, which is payment number two of the 2019 Fire Taxes. The check, in the amount of \$247,500.00, was received and deposited on June 27, 2019.

We received a monthly report, from the Howell Township Fire Bureau, for May 2019. We received an email, from Liberty Mutual Insurance, stating that Firefighter Digraitis has been released to full duty on June 5, 2019. We received the minutes from the Joint Board Meeting, which was held on June 6, 2019.

Joe gave a report on the Annual Audit, which was completed by Robert A. Hulsart & Company. Joe said that the Audit was clean and we are still doing a great job. # Chief's Report

Chief Michael Whitehill gave his monthly report for June 2019. The Chief asked to purchase the following items.

- 1) Twelve (12) Metal Cutting Blades for the K-12 Saws, from Grainger on State Contract.
  - 2) Ten (10) Scott SCBA Masks, from Firefighter One on State Contract.
  - 3) Repair of the Route 33 Fire Console, from Wireless Communications, for \$1,468.90.
- 4) Addition of ten (10) users for the Power DMS Training Program for an annual cost of \$782.30.

After some discussion, a resolution was offered by Bob Tice and seconded by Doug Howlett, approving the Chief's purchase requests. A roll call vote was taken.

The Chief asked the Board if they would approve the Annual Firefighter Physicals be given annually to Firefighters under the age of forty (40). Currently the Physical schedule is,

- 1) Every three (3) years up to age thirty (30).
- 2) Every two (2) years up to age forty (40).
- 3) Every year for anyone forty (40) years and over.

After some discussion, it was decided to keep the same schedule as we have been using for quite some time, no changes.

The Chief asked the Board about the newly adopted Social Media Policy. The Chief has some concerns about the New Policy and would like the Board to return to the old policy. After a long discussion, the Board said that they will be sticking with the newly adopted Social Media Policy.

#### Committees

Bob gave a report on the Executive Board Meeting which was held on June 27, 2019. Bob said that the rest of the Fire Districts do not seem to want to get the Radio Study Completed. The Howell Township Fire Districts have been talking about a radio study of the Howell Township Fire Radio System for years. Several, if not all, of the five Fire Districts have been having radio issues with both dispatching and communicating with Howell PD. From the beginning, Howell has never had a radio study completed to see if we could improve on what we have now. With the help of Chief Robert Lewis, of the Howell Township Fire Bureau, a proposal was received from Allegiant Wireless LLC. The scope of the Township Wide proposal includes 248 hours of work for a total of \$37,200.00. This cost, if all five Fire Districts agree, would be \$7,440.00 per District. As of this date, not all Fire Districts are in favor of getting the work completed. Howell Fire District 2, the Adelphia Fire Company, seems to have the most issues with the current radio system. Howell Fire District 2 had decided that they will contract this company to complete the work at their September 9, 2019 meeting. The Howell Township Fire Districts Joint Meeting is scheduled for Thursday September 5, 2019. District 2 will be looking for support with this project at that meeting.

Frank gave a report on the trucks and equipment as follows.

- 1) 2-90 was picked up from Atlantic Detroit Diesel on June 6, 2019. The truck does not run any better. Frank asked the Board what they want him to do next. It was decided to take the truck to Allied Diesel.
- 2) 2-68's vehicle broke down at Griebling School. The truck was towed to Lester Glenn Chevrolet on June 5, 2019. They replaced the fuel pump and one vapor hose.
  - 3) 2-99 was taken to PL Custom for and electrical issue on June 8, 2019.
  - 4) Ground ladders and Aerial 2-90 were tested by UL on June 10 &11, 2019.
  - 5) Defender repaired one leaking valve on 2-96.
  - 6) ABG Electric relocated one parking lot light at the Route 33 Fire Station.
- 7) Campbell Supply picked up 2-85 on June 27, 2019 for the final repair of the cascade system. Frank picked the truck up from them on June 28, 2019.
  - 8) The Gear Dryer at the Route 524 Fire Station is back in service.
  - 9) Frank repaired the pump shift on 2-96 on July 1, 2019.

#### **Old Business**

Frank said that he has been getting emails from Nick K.'s Insurance Company about an accident that Nick had while responding to a call on May 12, 2019. Frank asked the Board what they wanted to do with this issue. The Board said to notify VFIS and see if they would handle any part of this accident.

George said that he contacted Family Practice of CentraState to let them know that we added blood work to our Firefighter Physicals. George said that the new cost of our physicals would be as follows.

- 1) Charge for Physical, \$200.00.
- 2) Charge for EKG (40 years and older) \$50.00.
- 3) CDL paperwork completed at time of physical, \$40.00.
- 4) Charge for Hepatitis B Antibody, \$55.00.
- 5) Charge for Hepatitis B Vaccine, \$71.50 per vaccine.

Each Firefighter Physical is to include a history and physical examination, Audiometric Screening, Vision Screening, Pulmonary Function Testing, Lab work (CBC, CMP, Lipid Panel and Urinalysis) and Respirator Clearance.

After some discussion, a resolution was offered by George Patten and seconded by Bob Tice, to enter into an agreement with Family Practice of CentraState to complete Firefighter Physicals at the rates listed. A roll call vote was taken.

## **New Business**

We received a letter, from the Township of Howell, stating that our Backflow Preventer is due for the annual inspection. George notified Hughes Environmental to come and complete this annual inspection. Hughes completed the work and a copy of the certification was given to the Township of Howell.

With to installation of the Security Cameras at both Fire Stations, a proposed Video Surveillance Policy was drawn up by members of the Fire Company. It was decided to let everyone look over the proposed policy before the Board acts on it.

A discussion was had on the rear parking lot of the Route 33 Fire Station and possibly adding a small piece of asphalt near the Training Prop.

Firefighter Brian Prochnow asked the Board if they were in favor of replacing the current Aerial Truck. Mr. Prochnow said that a truck committee has been putting in a lot of hours researching a New Aerial Truck that would meet the Fire District's needs. Several of the Board Members said that they were in favor of replacing the 1996 E-One Platform with a new truck. A short heated discussion followed.

With no further business to come before the Board, the meeting was adjourned at 10:03 PM.
