Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received the minutes from the New Jersey State Association of Fire Districts meeting, which was held on March 7, 2009. We also received a notice of the next meeting to be held on June 6, 2009 at our New Fire Station. We received a letter from Verizon requesting a tax exemption letter from us. George mailed a letter back to Verizon on May 28, 2009, which explains our tax exemption. We received a workers compensation policy audit from Liberty Mutual. This audit stated that our old policy, which expired on March 20, 2009, was paid in full.

We received a letter from JCP&L stating that there will be a rate increase starting with our June, 2009 bill. We received a letter from New Jersey Natural Gas stating that they will be updating our gas meter with a small transmitter so they will be able to read the meter electronically. We received a service report from Absolute Fire Protection for work which was completed on 19-2-90. We received the report from Underwriters Laboratories for the inspection on our Aerial Truck. The repairs on mentioned on this report were completed be Absolute Fire Protection.

Legal

Joe read the resolution accepting the audit report for the year ended December 31, 2009. This resolution was adopted at the May 4, 2009 meeting. Joe had all the Board members sign the Annual Audit Review Group Affidavit. Joe then signed the same Affidavit. Joe recommended that we drop any legal action against the driver of the vehicle that destroyed some OPTICOM equipment at Fairfield Road and Route 33 in 2007. The Board agreed with Joe and will not pursue the matter any further. Joe told the Board that it could take a few more weeks to get the permit to install the radio tower because of furloughs going on in the Township.

Chief's Report

Chief Wayne Gravatt gave his incident report for the month of May, 2009. The Chiefs do not wish to purchase any items this month.

Committees

Frank gave a report on the Executive Board meeting held on May 28, 2009. Frank also gave a report on the trucks. 19-2-90 is being repaired at Absolute Fire Protection and they will also complete the annual service.

Old Business

George said that they had a meeting with BurMarc Construction and Jack Purvis on May 27, 2009 to discuss the punch list, which is still not completed. BurMarc said that all of the items on the list will be completed in 14 days. George also said that N. J. American Water has started removing the fire hydrants that we agreed on. The hydrant bill is still reflecting the old price and we will not pay this bill until it is corrected.

New Business

We received a letter from the Board of Fire Commissioners, Howell Township District #1. This letter stated that District #1 is interested in expanding District #2's response area within District #1. After some discussion, the Board said that we would invite District #1 to the July 6th meeting to further discuss the matter.

George said that Trinity Global, LLC, has asked to use the Fire Company land for a service project. Some discussion followed and it was decided that this would be a good thing to do. A motion was made by George Patten and seconded by Tom Ward, granting permission to use the Fire Company Grounds. Motion passed.

George said that we should get a New Jersey Permit for our standby generator. George said that it is a law that any emergency generator over 88kw has to be registered with the State. Further more a record has to be kept with when the generator was run, how long and for what reason. The record keeping has to be done for any emergency generator 45kw and over. This means that records need to be kept for both of our emergency generators. A resolution was offered by Harry Carter and seconded by Tom Ward, to get the needed permit and start the record keeping for both of our emergency generators. A roll call vote was taken.
