Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a letter, from New Jersey American Water, stating that a representative from SSI Dynata will be calling for a short survey. We received the minutes from the last New Jersey Association of Fire

Districts meeting, which was held on March 2, 2019. We received a statement, from New Jersey Motor Vehicle Services, for all abstract retrievals completed in April 2019.

We received an apparatus report, from Absolute Fire Protection, for the work on 19-2-90. We received two service reports, from EMR Power Systems, for the two service checks completed on our Emergency Generators on May 10, 2019. We received a monthly report, from the Howell Township Fire Bureau, which included January thru April 2019. We received two emails, from Fire Research, indicating that they no longer sell the Gear Dryers that we have. They said that most of the parts needed to repair the units are available at Grainger.

We received several emails from Prudential, concerning payments for DCRP. We received the minutes from the last Radio Committee meeting which was held on May 16, 2019. We received an estimate, from Allegiant, to complete a radio study for the Howell Township Fire Districts. This will be discussed later in this meeting. We received several emails, from Campbell Supply Company, stating that they have had the leaking Cascade Bottle repaired and are continuing to check it for any more leaks. So far it is holding 6,000 psi and they will be calling for a date to reinstall it.

Legal

Joe turned in an invoice, from Reliance Graphics, for their work on the 2019 Fire District Elections. This will be paid at the July 1, 2019 meeting.

Joe read a letter that he sent to Robert A. Hulsart and Company, stating that the Board was not involved in any litigation of any nature at the year ended December 31, 2018. This letter is part of the Annual Audit of the Board of Fire Commissioners. Joe also read over the Annual Audit and said that we have a clean Audit once again.

Joe gave a report on the proposed new Social Media Policy that was put together by Sendzik & Sendzik of Fire District number four, Howell Township. Joe said that the proposed policy would work for us. It is the intension of all five Fire Districts in Howell Township to adopt the same policy. After some discussion, a resolution was offered by Bob Tice and seconded by Doug Howlett, to adopt this New Social Media Policy. A roll call vote was taken.

Chief's Report

Chief Michael Whitehill gave his incident report for the month of May 2019. The Chief asked to purchase the following items.

- 1) Additional Chains, Binders, Hooks and Shoring Hammers to complete the Paratech Stabilization Equipment, from Continental Fire and Safety, for a total of \$2,532.00.
- 2) Additional Mics, Spare Batteries and Antennas for the New Radio Equipment, from Wireless Communications and Electronic, for a total of \$4,156.60 on State Contract #83909.

3) Five (5) Refill kits for current First Aid Kits, and three (3) complete Wall Mounted Fire Aid Kits, from Grainger on State Contract.

After some discussion, a resolution was offered by Bob Tice and seconded by Harry Carter, to purchase the items that the Chief requested. A roll call vote was taken.

Chief Whitehill said that he has signed an agreement with County Communications that states that they will sent out alerts on the I Am Responding App when they are requested to dispatch Station 19-2. This agreement states that this service will be done at no cost to the Fire District. The agreement also states that no one from Station 19-2 is to use any of the information from the IAR alert for any other reason not related to responding to the incident.

Committees

Bob gave a report on the Executive Board meeting, which was held on May 23, 2019. Bob also stated that we seem to be having issues with the Howell PD Dispatch. At times Dispatch will attempt to call us off an incident without any Fire Officers on location. At other times Dispatch does not seems to want to get us the resources that we requested. After some discussion, it was decided to arrange a meeting with Howell PD, to discuss these issues.

Bob read the proposed Howell Township Fire Radio Study from Allegiant. The total cost of this complex study would be \$37,200.00. Any work authorized and performed beyond the scope of work would be billed at \$150.00 per hour. The total cost would be divided equally between the five Howell Township Fire Districts. After some discussion, a resolution was offered by Harry Carter and seconded by Bob Tice, approving the very much needed study to be completed. A roll call vote was taken.

Frank gave a report on the trucks and equipment as follows.

- 1) 19-2-90 was sent to Atlantic Detroit Diesel, on May 10, 2019, for an engine power issue. They said that the truck is ok to use for now and is already scheduled for a more extensive evaluation on May 20, 2019. The truck was picked back up on May 11.
- 2) Campbell Supply picked up 19-2-85 to check the cascade system for leaks again on May 14, 2019. They found a leak in bottle #2 and removed the bottle to be repaired at Continental Fire and Safety. The truck was back in service, without this bottle, on May 17, 2019. The truck will be scheduled to have the bottle installed at a later date.
 - 3) 19-2-90 was taken to Atlantic Detroit Diesel for repair on May 20, 2019.

- 4) East Coast Emergency Lighting installed the new siren in 19-2-96 on May 28, 2019.
- 5) Defender rebuilt the four discharge valves on 19-2-96 on May 21, 2019.
- 6) Super Laundry Service repaired the Gear Washing Machine at the Route 524 Fire Station on May 22, 2019.
 - 7) Mike repaired the door open issue on 19-2-78.
- 8) The Gear Dryer at the Route 524 Fire Station had bigger issues. We purchased a new motor and fan blade and will be installing them soon.
 - 9) The new insurance cards have been installed in all Fire District Vehicles.
 - 10) Aerial and Ground Ladder testing is scheduled for June 10 and 11, 2019.

Old Business

A discussion was had on completing the Training Prop at the Route 33 Fire Station.

Doug said that G & L Lawn Service stood the fallen tree back up at the Route 33 Fire Station. They also installed cables to help several trees stay straight.

New Business

There was no new business.
