Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received an e-mail confirmation that Glatfelter's was in receipt of or loss claim for the fire on Thoroughbred Drive. We also received a check, minus \$100.00 deductible, for the replace of the three items. The items are one 50 foot length of 1.75" orange attack hose, one 10 foot folding attic ladder and one Little Giant ladder. The check, in the amount of \$623.99, was received and deposited on April 18, 2014. We received notification of our Commercial Package Policy from VFIS. This policy runs out on June 3, 2014 and will be renewed with VFIS. The notification stated that our deductible will increase to \$250.00 for the new policy and that the premium will be \$24,845.00 due by July 3, 2014. We received an overpayment check from the New Jersey Public Employees' Retirement System. The check, in the amount of \$402.00, was received and deposited on April 21, 2014

We received a notice from Ace American Insurance Company stating that they may not renew our policy for above ground fuel storage tanks. They said that we should contact our agent to submit the underwriting information necessary for the renewal process. George said that he would get in touch with VFIS next week to take care of this. We received a recall notice, from Spartan Chassis, for an issue with 19-2-75. Frank made a copy of the notice and gave it to Campbell Supply. We received a packet of information from Liberty Mutual as a result of our safety survey. This packet included work place safety guidelines and some recommendations.

Chief's Report

Chief Bob Tice gave his incident report for the month of April, 2014. Chief Tice gave a detailed report on the Thoroughbred Drive fire, where we lost three pieces of equipment. The Chief's would like to purchase the following items.

- 1) One Little Giant model 17 ladder from Continental Fire and Safety, for a total of \$218.00. This was one of the items lost in the Thoroughbred Drive fire.
- 2) One Alco Lite model FL-10, 10 foot aluminum folding ladder from Continental Fire and Safety, for a total of \$344.00. This was one of the items lost in the Thoroughbred Drive fire.
- 3) One 50 foot length of Ponn Supreme 1.75" orange attack hose from TASC Fire Apparatus, for a total of \$186.25. This was one of the items lost in the Thoroughbred Drive fire.
- 4) Send one TFT 1.75" nozzle out to be checked by the manufacturer through TASC Fire Apparatus. This nozzle was left inside the structure at Thoroughbred Drive during the fire.
- 5) Two Harrington 6" nst to 5" storz adapters from Continental Fire and Safety, for \$132.55 each and a total of \$265.10.
- 6) One pallet (36, five gallon pails) for Chemguard Class A Plus foam from TASC Fire Apparatus, for a total of \$3,330.00.
 - 7) Sixteen illuminating arrow stickers for hand lines from Foxfire, for a total \$143.28.
- 8) Six Bullard Eclipse batteries from Continental Fire and Safety, for \$59.37 each and a total of \$356.22.

He will get a contractor to look at these hose and give us an opinion of what, if anything, we should do. Tom also said that he mounted the AED in the hallway of the Route 33 Fire Station.

Chief Tice said that we needed to work on a sick leave policy. At the current, we have sick or injured Firefighters showing up to get credit. The Board said that they are waiting for the Fire Company to draw up a policy so they can adopt it.

New Business

Frank said that he would contact East Coast Flags and Flagpoles to see about repairing the flagpole at the Route 33 Fire Station.

Frank asked the Board if he could put the specifications together for the new Chief's Command Vehicle. The Board said to start the process and to be ready to go to bid before the August meeting.

Tom said that he received prices for phase one of the tree and shrubbery replacement at the Route 33 Fire Station. The first phase is the shrubbery along the front of the building and the price would be \$2,900.00. After some discussion, it was decided to wait on this project for now.
