## REGULAR MEETING

Notice of time, date, location and agenda of the meeting, to the extent then known, was duly published in accordance with the requirements of the "Open Public Meeting Act' at least 48 hours in advance of this meeting by posting and by publication in the official newspapers of the district.

The meeting was called to order by Vice-Chairman Doug Howlett, at 7:01 PM.

A Roll call was taken showing George Patten, Frank Biddle III, Harry Carter, Doug Howlett and Robert Tice present. Also in attendance was Joseph Youssouf, Board Attorney. The Chairman then led all in attendance with the Pledge of Allegiance. Please note that both Harry Carter and Joseph Youssouf were present via the telephone.

#### Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a report, from Hartford Steam Boiler, for the annual inspection of the boiler at the Route 33 Fire Station. We received a statement, from the New Jersey Motor Vehicle Services, for all abstract retrievals completed in December 2020. We received a Local Finance Notice, from the New Jersey State DCA, which contains the State approved increase for the 2020 LOSAP. The approved increase for Fire Districts is 2.6% with a maximum award of \$1,787.00. This increase was approved at our January 2021 meeting.

We received a second Local Finance Notice, which contains bid thresholds for New Jersey State Contracting Units. The thresholds are listed for both units with and without a Qualified Purchasing Agent. We received some preliminary pricing, from Wireless Communications and Electronics, for the upgrades to the Howell Fire Radio and Paging System.

#### Legal

Joe gave a report on the changes to the Fire District Election. The State has moved the elections from February 20, 2021 to April 20, 2021. This will now be a Tuesday election and will be held in person, if a registered voter wants to show up and place their vote. They can also ask for an absentee ballot to be mailed to them. The hours will remain the same from 2:00 PM to 9:00 PM. Any petitions for the office of Fire Commissioner will need to be in the District Clerks hands by March 22, 2021. Joe said that the voting machines will be quarantined until May 9, 2021.

Bob asked Joe if any other Fire Districts have a policy for JCP&L and the babysitting that we seem to do while waiting for them to arrive. Joe said that at least one Fire District has a policy and that he would try and get us a copy. Bob said that sometimes we sit and watch a downed power line for hours while waiting for JCP&L to show up.

## **Chief's Report**

Chief Greg Player gave his incident report for January 2021. The Chief would like to purchase the following items.

1) Up to ten (10) members to recertify CPR class at \$48.00 per. These classes will be online and hands on in house.

2) Replacement inhalation valves for SCBA masks. 5 or 10 from Firefighter One at \$4.40 each.

3) Ten (10) Majestic Nomex Hoods from Continental for a total of \$990.00.

4) Five (5) Cairns replacement helmet liners from Continental for a total of \$412.80.

5) Five (5) Cairns 1010 black helmets from Continental for a total of \$1,694.00.

Note: All Continental Fire & Safety equipment is on New Jersey State Contract.

After some discussion, a resolution was offered by Bob Tice and seconded by Harry Carter, approving the purchase requests. A roll call vote was taken.

Bob gave a report on the ongoing Howell Fire Radio Study and what the fix will be. Bob would like us to have Rich on retainer to be our expert at some of these meetings. Bob said that Wireless Communications is talking more money than Rich said it should cost. After a long discussion, a resolution was offered by Bob Tice and seconded by Frank Biddle III, to have Rich represent us at the next Radio Study meeting at a cost of \$150.00 per hour. Frank gave a report on the trucks and equipment as follows.

1) We received an invoice, finally, from AH Hoffman, for work performed on our fuel pumps over the last two (2) years. We added that voucher to the bill list in the January 4, 2021 Vouchers.

2) Campbell Supply came out and repaired several items on 19-2-78 and 19-2-85.

3) Frank replaced the door lock by the Aerial Truck twice in the last few weeks. The keypad failed in both locks. One of these bad keypads was sent back for possible warranty.

4) RK Electric has repaired most of the lights at the Route 33 Fire Station. He had to rent a man lift for some of the repairs.

5) Shore Business Solutions repaired the copier in the Chief's office. They also sent us a new toner for the Board's copier.

6) The bad exit light in the meeting room at the Route 33 Fire Station has been replaced.

7) Frank scheduled both Fire Stations to have the Fire Alarm inspections completed on February 12, 2021 with Complete Security Systems.

8) G & L Lawn service came out and up righted several trees at the Route 33 Fire Station.

9) TRT installed the repaired DVR at the Route 33 Fire Station.

10) The upgraded heating/air conditioning system at the Route 33 Fire Station has been completed and is working very well.

11) The New Utility Vehicle cab and chassis was scheduled to be manufactured during the week of January 22, 2021.

12) AH Hoffman also came out and resealed the fittings on the Diesel Pump at the Route 33 Fire Station.

13) Campbell Supply came out and replaced the water tank gauge and sensor on 19-2-75.

#### **Old Business**

Frank said that the purchase of the Nifty Lift Trailer Mounted Man Lift was cancelled because the price was over the bid threshold. Frank said that we would be able to purchase the Genie TZ-34 DC Trailer Mounted Man Lift off the GSA Contract Number GS07F0261V. The total price with all available options, included delivery to the Route 33 Fire Station, would be \$31,363.78. The Vendor that is on contract is One Source Equipment out of Graham Texas. After some discussion, a resolution was offered by Bob Tice and seconded by George Patten, to void last month's resolution and purchase the Genie Trailer Mounted Lift from One Source Equipment for \$31,363.78. We received an estimate, from RK Electric, to change the rear parking lot lights at the Route 33 Fire Station over to LED. There are seven lights on that system. We did change over the front driveway lights to LED several years ago and have not had any more issues with them. The cost for this upgrade would be \$7,135.02. This cost does not include the rental of a man lift because he was aware that we were purchasing one in the near future. After a long discussion, no action was taken.

A discussion was had on putting a Qualified Purchasing Agent on contract so when we needed one, we would have one. After a while, it was decided to not hire one as this time.
