RE-0RGANIZATION MEETING

The meeting was called to order by Chairman Harry Carter, at 7:01 PM.

A Roll call was taken showing George Patten, Frank Biddle III, Harry Carter, Doug Howlett and Robert Tice present. Also in attendance was Joseph Youssouf, Board Attorney. The Chairman then led all in attendance with the Pledge of Allegiance.

Chief's Report

First Assistant Chief Dan Roth gave his incident report for the month of April 2021. The Chief would like approval to surplus the old Bullard TIC's, six (6) total, to the Monmouth County Fire Academy. After some discussion, a resolution was offered by George Patten and seconded by Harry Carter, declaring the Six (6) Bullard TIC's as surplus and donate them to the Monmouth County Fire Academy. The Chief asked for approval for the following.

- 1) Request to enter into an agreement with Minerva Cleaners to provide loaner sets of Turnout Gear while our Gear is being repaired. We have several, about ten (10), sets of Turnout Gear that needs repair. This would allow our Firefighters to remain active while their Gear is being repaired. The cost for the Loaner sets is \$60.00 per month, plus the cost of the repair.
- 2) Send two (2) Firefighters to All Hands Fire Equipment for RIT Operations at a cost of \$325.00 each.

3) Send two (2) Firefighters to All Hands Fire Equipment for RIT Awareness at a cost of \$25.00 each.

Second Assistant Chief Tim McKay asked for approval to purchase two (2) New Laptop Computers from Best Buy for \$2,090.99 each. A long discussion followed with George saying that he could most likely get

a better price going through the Board's account. It was decided to table this discussion until the June meeting.

Chief McKay also asked for the approval to order the New Chief's Command Vehicle, now that the 2021 Fire District Budget has passed. There is \$80,000.00 built into the 2021 Fire District Budget for this vehicle. The prices are as follows.

- 1) One (1) 2021 Chevrolet Suburban 1500, four (4) wheel drive, on State Contract #A89939 with Hertrich Fleet Services, for a total of \$44,770.00. This price includes several available options.
- 2) One (1) Command Vehicle Upfit, on State Contract #T-0166 with Elite Vehicle Solutions, for a total of \$30,481.00.
- 3) One (1) paint the Suburban roof white to match existing fleet from Branning's Auto Body, for around \$2,000.00.

After some more discussion, a resolution was offered by Bob Tice and seconded by Harry Carter, approving the New Chief's Command Vehicle Purchase, including the Upfit and the roof paint. A roll call vote was taken.

Committees

Bob gave a report on the progress with the Howell Radio Study and the repairs that are needed for the fix. The Township of Howell has hired Rich Touroonjian and Allegiant Wireless to see the project through.

Bob also said that the State is requiring a resolution from the Board, stating that we will agree to pay at least 25% of the cost of the proposed Warning Light at the entrance to the Route 33 Fire Station. This cost, our share, would be around \$19,000.00. After some discussion, a

resolution was offered by Frank Biddle III and seconded by Bob Tice, to agree to pay for at least the 25% of the cost. A roll call vote was taken.

- 2) 19-2-85 had an issue with the light tower and Campbell Supply came out and repaired.
- 3) Campbell also came out for the repair of the hose bed lights on 19-2-75.
- 4) The New Chassis Cab did come in at Hertrich Fleet Services and will be getting the roof painted before being shipped up to Dejana for the body and up fit.
 - 5) 19-2-88 was taken to The Front End Shop for repairs and is back in service.

New Business

Viking Pest Control asked to park up to four (4) pickup sized vehicles at the Route 33 Fire Station for up to two (2) months. Frank called around to get at least three Fire Commissioners approval for this. Frank called Viking back to agree with the parking of vehicles for the two (2) months. An agreement was signed by Viking which gives approval through the end of June 2021.

Toby Roe asked the Board if an old light bar in the electrical room could be used by the State Forest Fire Service for one of their vehicles. After some discussion, a resolution was offered by George Patten and seconded by Bob Tice, declaring this old light bar as surplus and to donate it to the State Forest Fire Service.
