We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a statement, from New Jersey Motor Vehicle Services, for all abstract retrievals completed in September 2021. We received an email, from the Howell Township Manager, stating that he is in receipt of our Resolution containing Fire Commissioners salaries for 2022. We received a letter, from Access Health, stating that there will be a price increase in 2022.

Legal

Joe read over the new budget requirements from the State. The election and Budget Referendum is scheduled for February 19, 2022. Joe moved on to the Introduction of the 2022 Fire District Budget. Joe read the Proposed 2022 Fire District Budget as follows.

This Budget would have a tax rate of \$0.042. After some discussion, a resolution was offered by George Patten and seconded by Doug Howlett, formally introducing the 2022 Fire District Budget as read. A roll call vote was taken.

George said that we should make a resolution to approve using the \$404,700.00 from the unrestricted fund balance to offset the 2022 Fire District Budget. After some discussion, a resolution was offered by George Patten and seconded by Bob Tice, approving the use of \$404,700.00 to offset the 2022 Fire District Budget. A roll call vote was taken.

1) One (1) Stihl Rescue Chainsaw with Four (4) replacement carbide rescue chains from Continental Fire & Safety for a total of \$2,578.13.

2) 2022 Officer Helmet Frontals from Continental Fire & Safety for a total of \$467.20.

3) Twenty (20) assorted sizes of Pro-Tech 8 Fusion-Pro Structural Firefighting Gloves from Continental fire & Safety for a total of \$1,360.80.

4) Four (4) Innovative Products Magnetic Mic Holder Kits from M & W Communications for a total of 139.80.

5) One (1) Five Gallon Bucket of Enzymatic Detergent for \$328.00 and One (1) Four Gallon Bucket of Sanitizer Bleach for \$223.00 from Ecolab for the Gear Washing Machine at the Route 524 Fire Station.

6) Three (3) Milwaukee 2136-21 M18 Rocket Tower Portable Lights with charger from Cooper Electric for a total of \$2,043.00.
