# **Communications**

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. Several emails were received and sent regarding the Howell Township Fire Radio Study and the proposed repair of same. We received the minutes from the Joint Board meeting, which was held on March 3, 2022. We received a communication, from Sakoutis Brothers Disposal, stating that Republic Services will be taking over the dumpster service at the Route 33 Fire Station.

We received a check, from Glatfelter Insurance Group, which is returned overpayment on our Vehicle Insurance Policy. The check, in the amount of \$100.60, was received and deposited on April 1, 2022. We received a check, from the Township of Howell, which is our first payment for the 2022 Fire Taxes. The check, in the amount of \$233,750.00, was received and deposited on March 30, 2022.

# Legal

Joe gave a report on the Proposed Howell Fire Radio upgrade and what we will need to do. If we decide to take on the cost of the monopole and infrastructure at the site of the Route 33 Fire Station, the cost would be around \$365,000.00. There are pros and cons for us to take on this part of the Radio System. A very long discussion was held on this subject.

Joe also said that he has been in contact with the Asbury Park Press in order to straighten out the billing issue.

# **Chief's Report**

Chief Dan Roth gave his incident report for the month of March 2022. The Chief asked to purchase the following items.

- 1) Five (5) Ex-Chief Helmet Frontals, from Continental Fire & Safety, for a total of \$308.00.
- 2) Two (2) or Five (5) Uniden SDS200 Police Scanners for a cost of around \$699.00 each from an online store.

After some discussion, a resolution was offered by Frank Biddle III to purchase the items that the Chief requested. This resolution was lost for the lack of a second.

A resolution was offered by Bob Tice and seconded by Doug Howlett, to purchase the Ex-Chief helmet frontals from Continental. A roll call vote was taken.

The Chiefs were asked about the lack of response to Fire Calls lately. This issue is for the active members and also the Chief Officers. The Chiefs said that they are aware of the response issue and are trying to come up with a fix.

#### Committees

Frank gave a report on the trucks and equipment as follows.

- 1) 2-66's vehicle was repaired at East Coast Emergency Lighting.
- 2) The New 2-98 was dropped off at East Coast Emergency Lighting to get some issues repaired and also the lights programmed. The company that built the truck was unable to do any programming.
  - 3) Frank took 2-66's vehicle to Safe Lite to have a stone chip repaired.
- 4) The quote for the repairs on 2-78 was \$4,577.51 and Campbell was told to go ahead and order the parts and complete the repair.
- 5) The batteries were replaced on 2-76 and the truck was taken to Allied Diesel for the charging issue.
  - 6) The 2021 Chief's Vehicle was dropped off at Brannings for repair on April 3, 2022.
- 7) Frank was told that the Genie Trailer Boom Lift was shipped on March 18, 2022. But don't get excited because we have not heard anything since.

- 8) 2-93 was repaired at Freehold Ford. The rear fuel tank shield was replaced.
- 9) 2-93's Fire Pump Engine would not remain running during a recent brush fire and was taken to County Line Hardware for repair. They fixed and serviced the unit the same day.
- 10) One of our Quick Vent Saws and also the two donated Quick Vent Saws were taken to County Line Hardware for repair and picked up in two days.
  - 11) Chief Roth had his vehicle serviced at Jiffy Lube.
- 12) The Hot Water Heater at the Route 524 Fire Station was replaced, and the Gear Wash Machine is back in service.
- 13) The Tanker parts should ship around the end of June 2022. Frank told Defender to go ahead and order the parts. We should approve this repair.
- 14) Campbell was called to check a generator issue on 2-75. They came out and found the unit to be operating properly.
  - 15) Frank purchased a piece of aluminum from Fazzio to mount tools on 2-98.

After some discussion, a resolution was offered by George Patten and seconded by Doug Howlett, approving the pump repair on 2-96 with Defender Emergency Services.

Bob said that some of the flashing is coming off the training prop.

After some discussion, a resolution was offered by George Patten and seconded by Kathleen Carter, to have Access Health complete our Firefighter Physical for this year. A roll call vote was taken.
