Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a check, from VFIS Claims Management, for the OPTICOM equipment damaged during a motor vehicle accident at Route 9 and Strickland Road. The check, in the amount of \$5,450.00, was received and deposited on June 10, 2022. They will also reimburse us for the labor to install the parts once we know what that figure is. We received a check, from the Township of Howell, which is payment number two for the 2022 Fire Taxes. The check, in the amount of \$247,500.00, was received and deposited on June 30, 2022.

We received a check, from VFIS Claims Management, for a special meeting we had with the OPTICOM Contractor for the repair of the system at Route 9 and Strickland Road. The check, in the amount of \$422.00, was received and deposited on July 2, 2022. An email was sent to the Chairman of the Board, of Howell Fire District Five, asking to please repair the OPTICOM System at the intersection of Route 9 and West Farms Road.

Joe handed out the notice of the Joint Board Meeting scheduled for July 21st at the Southard Fire Company starting at 7:30pm. Joe also gave a report of the Prevailing Wage Act and how that affects the Board of Fire Commissioners.

Chief's Report

Chief Dan Roth gave his incident report for the month of June 2022. The Chief asked to purchase the following items.

- 1) Policy Management Software System. Doc Tract for fifty (50) users at a cost of \$1,725.00 annually, plus a onetime implementation fee of \$950.00.
- 2) Repair of some wind damage to the Training Prop at the Route 33 Fire Station by D & D Contractors for a total of \$1,970.00.
- 3) Turnout Gear. Five (5) sets of Turnout Gear, from SAFE-T, on State Contract for \$4,266.95 each. Total of \$21,334.75.
- 4) Two (2) pair of XXXL Pro-Tech 8 Fusion, Structural Firefighting Gloves, from Continental Fire & Safety for a total of \$124.00.
- 5) Advanced Vehicle Extrication Class (8 hours) from ESI Equipment, for up to thirty students, for a total of \$2,755.00.
- 6) High Voltage Vehicle Battery Fire Awareness (3 hours), from ESI Equipment, for a total of \$595.00.
- 7) High Voltage Vehicle Battery Fire Operations, from ESI Equipment, for a total of \$1,640.00.

After some discussion, a resolution was offered by George Patten and seconded by Kathleen Carter, granting the Chief's purchase requests. A roll call vote was taken.

Committees

Frank gave a report on the trucks and equipment as follows.

- 1) Three of our vehicles were serviced at Jiffy Lube. 2-67, 2-68 and 2-98.
- 2) Hose testing is scheduled for July 8, 2022.
- 3) Pump testing is scheduled for July 25, 2022.
- 4) Route 33 Fire Station house air system was out of service for several days while we replaced a totally rotted out piece of pipe. This system needs to be upgraded as soon as possible.
 - 5) Campbell Supply repaired the 12-volt power issue on 2-75.
 - 6) Campbell Sully also replaced the broken turn signal switch on 2-85.
 - 7) Defender said that the gearbox parts for 2-96 might ship next week.

Bob gave a report on the Howell Radio System and the repair of it. Bob also said that this will be the topic of discussion at the July 21 Joint Board Meeting at District #3.

Old Business

Bob said that the State is still working on the Warning Light at the entrance to the Route 33 Fire Station.

George said that he is working with Benchmark to complete a Workers' Compensation Audit for our 2020 and 2021 Policies.

New Business

George asked if we need to keep renewing with Thomson Reuters-West every year. Joe said that he has all the same updates and that we do not need to keep updating. Frank said that he would enclose a letter to that fact with this evening's payment.

George said that the Air Conditioning at the Route 33 Fire Station is still being repaired. This work is still on warranty.

With no further business to come before the Board, the meeting was adjourned at 9:07 PM.
