### Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received the minutes from the New Jersey State Association of Fire Districts meeting, which was held on March 5, 2022. We received a letter, from Edwards Tire Company, stating that they would be closing the business at the end of May 2022. We received two Service Reports, from EMR Power Systems, for the two Service Checks completed on our Emergency Generators. These services were completed on May 24, 2022.

We received a Kitchen System Report, from Jersey Coast Fire Equipment, for the annual inspection of the Amerex Liquid System at the Route 524 Fire Station. The report states that the system is compliant with NJAC 5:70-3. We received an email, from the Howell Township Fire Bureau, stating that received our authorization for the installation of six New Fire Hydrants along Vanderveer Road and Industrial Court. We received an estimate for the OPTICOM Equipment that was destroyed during a Motor Vehicle Accident at the intersection of Route 9 and Strickland Road. We also received a copy of the Police Report for that incident.

## Legal

Joe gave a report on a letter received from the State of New Jersey. This letter was about the Introduction to the Office of Information Privacy. Joe said that this was about what's called Daniel's Law.

## **Chief's Report**

Chief Dan Roth gave his report for the month of May 2022. The Chief asked to purchase the following items.

1) Doc Tract, a Policy Management System, for up to 75 users, for \$2,208.00 plus a onetime implementation fee of \$950.00, for a total of \$3,158.00.

2) Six (6) Additional flashing Fire Station mounted lights, from Fardale Emergency Lighting for a total of \$300.00.

After a long discussion about the Doc Tract System, a resolution was offered by George Patten and seconded by Kathleen Carter, to purchase just the lights from Fardale at this time. A roll call vote was taken.

2<sup>nd</sup> Assistant Chief Smith asked the Board to send a letter to Fire District #5, to see if they will repair the OPTICOM System at the intersection of Route 9 and West Farms Road. This system has not worked for some time, and we use that intersection quite a bit. This has been an ongoing problem for around six months. Frank was asked to write a letter expressing our concerns.

The Chiefs also asked the Board if they would be up to replacing the old pressure washer with a new one. This unit is probably 20 years old and is broken more than running. The Chiefs were asked to get some prices for a new unit.

### Committees

Frank gave report on the trucks and equipment as follows.

1) 2-98 has been placed in service. The truck is still a work in progress. The four battery filters were installed and are working as planned.

2) Campbell Supply was called to check on a 12-volt battery issue with 2-75 and a turn signal issue with 2-85.

3) 2-98 went back to East Coast Emergency Lighting for an issue with programming.

4) 2-98 went to Lester Glenn Chevrolet for a vibration. They rebalanced the tires and the problem is gone.

5) Training on the Genie Trailer Boom is scheduled for July 13<sup>th</sup> at 5PM.

6) We purchased a Heavy-Duty Trailer Hitch for 2-98.

7) There is a pretty big leak in the Station Air System at the Rout 33 Fire Station.

8) Need approval for Annual Hose Testing with IAA.

9) Need approval for Annual Pump Testing with Mistras.

10) Need approval for Annual Aerial Testing.

After some discussion, a resolution was offered by Doug Howlett and seconded by George Patten, approving the Annual Tests for the Hose, Pumps and Aerial Truck. A roll call vote was taken.

Bob gave a report on the Radio Study and the repair of it. Bob said that with the Township Manager being replaced, it's almost like starting over. The New Manager is not very familiar with the Radio System, and it could take a while for him to get up to speed.

#### **Old Business**

Bob gave a report on the Proposed Warning Light at the entrance to the Route 33 Fire Station. The State said that they just finished the survey stage of the project.

Bob started the discussion on the CDL requirement that the Board put in place several years ago for all Drivers of District owned equipment. Bob said that the State of New Jersey does not require a CDL for Fire Trucks. After a long discussion, it was decided to keep the CDL Requirement at this time.

Bob said that the State of New Jersey does not require all Structural Firefighting Turnout Gear to be replaced after the age of ten years. If the gear is still in good shape, it may be used long after the ten-year mark.

George said that he finished the Audit with Benchmark today. Benchmark was our old Workers' Compensation Insurance Company.

### **New Business**

Frank asked about adding the Trailer Mounted Genie Boom to our insurance policy. After some discussion, a resolution was offered by George Patten and seconded by Doug Howlett, to add coverage on the Genie Trailer Boom. A roll call vote was taken.
