We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a statement, from the New Jersey Motor Vehicle Services, for all abstract retrievals completed in September 2022. We received an Affidavit of Publication, from the Asbury Park Press, for the publishing of the Notice of Special Election on October 29, 2022.

We received a Service Report, from Absolute Fire Protection, for the work completed on 19-2-90 in October. We also received two inspection reports, from Industrial Inspection & Analysis, for the inspection of 19-2-90 and the ground ladders on 19-2-90. We received a report, from Mistras Group, for the pump tests that were completed on July 25, 2022.

Legal

Chief's Report

Chief Dan Roth gave his incident report for the month of October 2022. The Chief asked to purchase the following.

- 1) One (1) pair of Haix Eagle Air Leather Structural Firefighter Boots from SAFE-T for a total of \$391.93.
 - 2) Five (5) H41 Interceptor Nomex Hood from Firefighter One for a total of \$614.50.
 - 3) CPR Class for up to twenty-Five (25) by Team Life for \$1,750.00.
- 4) High Voltage Battery Fire Awareness and Operations by ESI Equipment for a total of \$1,715.00. This is a two-part training class, classroom, and hands on.
- 5) Training with Freehold Township (16-1). Truck and Bus Operations for \$300.00 per Firefighter.

After some discussion, a resolution was offered by Kathleen Carter and seconded by George Patten, approving the Chief's requests. A roll call vote was taken.

Bob asked the Chief to update the Fire Company SOPs after the Brickyard Road fire.

Tim said that the new AEDs were in service and that the eight (8) old ones were traded in to Team Life.

Committees

Frank gave a report on the trucks and equipment as follows.

- 1) 19-2-90 is back from Absolute and is in service. We are looking into replacing the two (2) rear portable lights on the rear body of the truck with LED.
- 2) The electric service that runs from the Firehouse to the Fuel Pumps at the Route 524 Fire Station needs replacement. The insulation on most of the service is nonexistent.
 - 3) One (1) battery was replaced on the 2009 Suburban Chief's Vehicle.
 - 4) Both batteries were replaced on 2-66's Command Vehicle.
 - 5) 19-2-93 will be going out for work at Freehold Ford sometime soon.
- 6) We would like to install vent visors on 2-88 before the winter gets here. They would cost around \$100.00 or less.
 - 7) Campbell Supply came out and repaired a heat issue on 19-2-75.
 - 8) Clean Air Company came out to repair the drop for 19-2-85.
 - 9) Chief Roth had his vehicle serviced at Jiffy Lube.
 - 10) We are having starting issues with 19-2-88 and it will be worked on tomorrow.
 - 11) We will be replacing the two (2) backup lights on 19-2-78. We ordered LED lights

Old Business

George said that the latest N. J. American Water Hydrant Invoice did include the updated pricing. They did raise the cost per hydrant per month by \$7.14. We will have to see if we have enough money in that line to cover this increase for the remainder of the year.

Kathleen said that the 2009 Suburban Command Vehicle is listed on GovDeals with the auction ending November 21, 2022, at five PM.

Bob said that he has communicated with the DCA about projects we would like to do at both Fire Stations. There has not been much agreement on whether we can complete these projects or not. Bob said that we will proceed as we have discussed and move forward.

New Business

George said that since our referendum was deemed not completed properly, we will have to go about funding the Radio Project another way. We will need to use \$800,000.00 from Capital Reserve to pay our share on the Howell Radio Project. This would mean that we will no longer be included in the Township Bond, and we will just pay for the project as we go along. In order for this to happen, we need to hold a Special Meeting to gain voter approval to use the \$800,000.00. After lots of discussion, a resolution was offered by George Patten and seconded by Bob Tice, to hold a Special Meeting on November 22, 2022, from 6PM to 9PM, at the Route 33 Fire Station.
