REGULAR MEETING

Notice of time, date, location and agenda of the meeting, to the extent then known, was duly published in accordance with the requirements of the "Open Public Meeting Act' at least 48 hours in advance of this meeting by posting and by publication in the official newspapers of the district.

The meeting was called to order by Vice Chairman, Doug Howlett, at 8:00 PM.

A Roll call was taken showing George Patten, Frank Biddle III, Doug Howlett, Robert Tice, and Kathleen Carter present. Chairman Tice was present via telephone. The Vice Chairman then led all in attendance with the Pledge of Allegiance.

A motion was made by George Patten and seconded by Kathleen Carter; to approve the minutes of the last meeting held on January 2, 2023, motion carried.

Due to this being the meeting where we make the LOSAP payment, George Patten offered a resolution raising the LOSAP contribution per qualified Member, to the new State Approved maximum. For 2022, the State of New Jersey raised the maximum by 7.3%. This will be a total of \$1,936.00, for each qualified Firefighter. Also please note that Corebridge Financial purchased VALIC, and will be our LOSAP Company going forward. This resolution was seconded by Kathleen Carter, and a roll call vote was taken.

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received a statement, from the New Jersey Motor Vehicle Services, for all abstract retrievals completed in December 2022. We received confirmation, from the State of New Jersey Motor Vehicle Services, that we surrendered the license plates for the 2009 Chevrolet Suburban. We also received a Credit Statement, from Glatfelter Insurance Group, for dropping the vehicle insurance on the 2009 Chevrolet Suburban. This Credit, in the amount of \$403.41, should be applied to our renewal in June 2023.

We received an email, from Richard Braslow, stating that we have advertised the 2023 Howell Township Joint Board meeting dates in the Asbury Park Press and also with the Township Clerk. We received a response, from the Howell Township Clerk, for our requested items that need to be addressed for the 2023 Primary and General Election. The Township said that they will accommodate these requests. We received two Alarm & Detection Equipment Test Reports, from Complete Security Systems, for the January 26, 2023, annual inspections at both Fire Stations.

We received the fully executed Shared Services Agreement from the County of Monmouth. We received a packet, from Citizens Bank, containing information about the purchase of Investors Bank. The actual take over starts on February 21, 2023. We are being told that we can still use all the checks we just received from Investors.

Legal

Frank gave all the 2023 Election information to the Monmouth County Board of Elections for the upcoming Annual Election on February 18, 2023. This included the Names of the two candidates running for the one seat on the Board of Fire Commissioners and also the 2023 Budget question.

George said that we should act on the Shared Services Agreement, with the Township of Howell, relative to the Fire Districts share of the cost of the communications infrastructure. Chief Dan Roth gave his incident report for the month of January 2023. The Chief asked to purchase the following item.

1) Annual flow testing of 43 SCBA's by Firefighter One, on State Contract, for a total of \$1,935.00.

The Chiefs asked the Board about installing some cameras inside of the two Fire Stations. The Board said that it would not be a bad idea, and would need some prices and the amount of cameras needed.

Committees

Frank gave a report on the trucks and equipment as follows.

1) Campbell Supply came out to repair an issue with the light tower on 2-85.

2) Frank set up an account with Van Wickle Auto Supply.

3) We are still working on the CO Sensors in the engine bays of the Route 33 Fire Station.

4) The Brow Light (Scene Light mounted on the front of 2-78) has burnt out. We are waiting on prices from several vendors for this light, as well as the two portable Scene Lights mounted on the rear body of 2-90 and also the two Cab Scene Lights on the side of 2-78. Would like permission to go with the lowest vendor.

5) 2-90 will be going to Absolute for a blown hydraulic ram on the right front jack.

6) Hoffman was called to repair a leak on the Diesel Pump at the Route 524 Fire Station.

7) Absolute did come out and repaired a power issue with the front bar lights on 2-90.

8) The two new door locks have come in.

9) 2-68's vehicle was sent to Sea Coast for repair of some rear axle leaks and also service to the driveline.

10) We purchased a fairly cheap Air Compressor for the Route 524 Fire Station. The old one blew up and we needed something to get us by until the Station Air System can be installed.

11) We now have at least four (4) old Air Compressors to sell on Gov Deals.

12) 2-67 took his rig to Lester Glenn for a couple recalls.

13) We received a quote, from RK Electric, for the repair of the electric service from the Building to the Fuel Pumps at the Route 524 Fire Station. The cost would be \$1,200.00.

After some discussion, a resolution was offered by George Patten and seconded by Kathleen Carter, to purchase the five Scene Lights from the lowest vendor and to have RK Electric make to necessary repairs to the Fuel Pump Service. A roll call vote was taken.

A New, non-color, Sharp Copier/Fax/Scanner/Printer would cost around \$2,407.00. This would be purchased through Shore Business Solutions on the Sourcewell Co-Op. This would allow them to return to active service sometime in the next two years without losing the funds in their account. Motion passed 4 to 1.

Frank said that we have received some information on the current GSA Per Diam totals for several cities around the Country. The rate in the Indianapolis area is \$69.00 per day. After some discussion, a resolution was offered by George Patten and seconded by Kathleen Carter, to raise our stipend to \$70.00 per day for each Firefighter attending the FDIC 2023.
