George responded to this email. We received an email, from the New Jersey Motor Vehicle CAIR division, asking about two Abstract Retrievals we completed in May 2023. Frank responded with the paperwork requested.

# **Chief's Report**

Assistant Chief Tim McKay gave the incident report for the month of May, 2023.

## **Committees**

Frank gave a report on the trucks and equipment as follows.

- 1) 2-78 was serviced at Defender. It will be going back when the new Arrow Stick comes in.
- 2) Defender serviced 2-96. They will be returning to replace the engine air filter and also the engine belts.
- 3) Super Laundry sent a repair company out to check some issues with the Route 524 Fire Station Gear Wash Machine. They ordered some parts and will return when the parts arrive.
  - 4) The State should be repaying the entrance to the Route 33 Fire Station soon.
- 5) Clean Air came out and adjusted the drop for 2-85 again. It seems to be working nice now.
  - 6) 2-68 had his vehicle serviced at Jiffy Lube.
- 7) We ordered and received some replacement parts for the bed cover on 2-98. These parts were on warranty.
- 8) Frank purchase flagpole parts from Acme/Lingo for the Route 33 Fire Station. A Board account was opened for the next time we need parts.
  - 9) Campbell came out and repaired the light tower on 2-85.
- 10) R. K. Electric installed outlets for the New Hot Water Pressure Washer at both Fire Stations.
- 11) R. K. Electric also repaired the wiring going out to the fuel pumps at the Route 524 Fire Station.
- 12) Frank called United Rental about performing the annual inspection on the Trailer Mounted Genie Lift.
  - 13) Shore Business Solutions came out and repaired the Chief's copier.
- 14) We received a quote, from Weilgus & Sons, for two replacement case assemblies for the Route 33 Fire Station. The quote is for \$553.80, which includes shipping.

After some discussion, a resolution was offered by Kathleen Carter, and seconded by Doug Howlett, to have United Rental perform the Annual Inspection on the Genie Lift, and to purchase the lock parts from Weilgus & Sons. A roll call vote was taken.
