## Chief's Report

Chief Brian Prochnow gave his incident report for the month of October, 2013. The Chief stated that 19-2-76 was involved in a minor accident during a drill on October 27, 2013. Chief Engineer Biddle was in the process of getting an estimate for the repair. The Chief asked to purchase the following items.

- 1) Heads up display upgrade for four (4) SCBA, from Firefighters Equipment Company, on State Contract # A80961, for a total of \$5,031.40.
- 2) Twelve (12) HT1250 Portable Radio batteries, from Quality Communications, on State Contract # A83909, for a total of \$460.80.
- 3) A Muratec model MFX-3530, multi-functional copier, from Shore Business Solutions, for a total of \$1,895.00.

After some discussion about the copier, a resolution was offered by Tom ward and seconded by Doug Howlett, to purchase the items the Chief requested. A roll call vote was taken.

Chief Prochnow said that the Route 33 Fire Station could meet the requirements for a Type 1 training facility. Brian also stated that the Fire Act Grant Program is opening up today and that we could possibly ask for a small utility truck with a lift gate. Chairman Carter asked the Chief to put together a set of specs and that he would complete the paperwork for the grant.

## **Committees**

Frank gave a report on the Executive Board meeting, which was held on October 24, 2013. The Executive Board voted to replace the aging Comparator at Police Dispatch for a total cost of \$14,798.00. Each Fire District started putting \$5,000.00 in their budget in 2013 for the upkeep on any radio equipment. The cost per District would be \$2,959.60. A resolution was offered by Tom Ward and seconded by Harry Carter, to pay our share of the cost when the bill comes in. A roll call vote was taken.

- 4) We will be scheduling 19-2-96 for service in early December.
- 5) 19-2-99 was taken for an oil change at Jiffy Lube.
- 6) 2-68 had his vehicle serviced at Jiffy Lube.
- 7) 19-2-76 was involved in a minor accident during a drill on October 27, 2013. Frank called the insurance company on October 28, 2013.

#### **Old Business**

George said that the Backflow Preventer, at the Route 33 Fire Station, was inspected and the report was submitted to the Township.

George also said that he has called the State about the Annual Boiler Inspection at the Route 33 Fire Station. He has not heard back from them as of yet.

Tom said that Twin Pond Farms will look at the trees at the Route 33 Fire Station and give us an idea as to which ones need replacing. They did say that it is too late to do anything this year.

### **New Business**

We received a contract, from Shore Business Solutions, for the copier in the Board's office. This is an annual agreement for repairs and would cost \$200.00.
