#### **REGULAR MEETING**

Chief Michael Banasz read his incident report for the month of October 2017. The Chief asked to purchase the following items.

- 1) Upgrade the emergency and work lights on 19-2-93 to LED. All labor and supplies are on State Contract #s 81336 and 81338, for a total of \$8,895.54.
- 2) Weather station repair parts for both Fire Stations, from Peet Brothers Company, for a total of \$637.00.
- 3) Opticom upgrades for two intersection, from Signal Control Products, for a total of \$17,190.00. These parts are only available from this vendor.
  - 4) Annual SCBA Mask fit tests, from CNP Fittest of New Jersey.
