### Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received an email, from the Howell Township Fire Bureau, which is an estimate of what it would cost to upgrade to Townships Fire Communications System. This is for 2018 budget purposes. We received two Service Reports, from EMR Power Systems, for the service checks completed on our two Emergency Generators on August 24, 2017.

We received a check, from the Township of Howell, which is payment number 3 of 4 for the 2017 Fire District Taxes. The check, in the amount of \$275,000.00, was received and deposited on September 28, 2017. We received a check, from Glatfelter Insurance Group, which is a return premium for cancelling the insurance on the old 19-2-85. This truck was sold to Atlantic Highlands earlier this year. The check, in the amount of \$1,227.33, was received and deposited on September 23, 2017. We received an email, from Brindlee Mountain Fire Apparatus, stating that they are still working on selling our 19-2-74.

## Legal

Joe gave a report on the 2018 Budget timeline and the upcoming Fire District Election. Joe also said that he turned over to the Auditor the Group Affidavit and the Resolution Accepting the Audit for the Year Ended December 31, 2016.

## **Chief's Report**

Chief Michael Banasz gave his incident report for the month of September 2017. The Chief also said that he has one price for the UniMac Gear Washer/Extractor for the Route 33 Fire Station. The Chief stated that he is trying to get at least two more prices for the November meeting.

The Chief asked the Board if he could get rid of some old Globe Firefighting Gear and Boots. This equipment is out of date and no longer meets NFPA Standards. After some discussion, a resolution was offered by Tom Ward and seconded by Doug Howlett, declaring approximately 15 sets of Globe Firefighting Gear and Boots as excess equipment. A roll call vote was taken.

The Chief also turned in the 2018 proposed Fire Chiefs Budget.

### Committees

Tom gave a report on the Executive Board Meeting, which was held on September 28, 2017.

A report was given on the trucks as follows.

1) Campbell Supply is working on the OPTICOM System on 19-2-85.

2) Route 33 Fire Station Breathing Air Compressor is out of service. Waiting on Continental for an update on what repairs are required.

3) The annual pump tests are scheduled for November 9, 2017 with Fire One.

4) The batteries were replaced on 19-2-90.

5) 19-2-68's vehicle was repaired at the Front End Shop.

6) The Defib at the Route 33 Fire Station needs a new battery.

7) Clean Air Company sent us the annual contract for the exhaust systems at both Fire Stations. The cost of this contract is \$1,161.00.

After some discussion, a resolution was offered by Tom Ward and seconded by Doug Howlett, to enter into the contract with the Clean Air Company and to also purchase a new battery for the Defib at the Route 33 Fire Station. A roll call vote was taken.

After that discussion, the 2018 Fire Chiefs Budget was adjusted to \$100,000.00 and an additional \$110,000.00 was proposed for the purchase of a New Utility Vehicle with Snow Plow Attachment. These figures will be added to the proposed 2018 Fire District Budget, which will be introduced at the November  $6^{th}$ , 2017 meeting.
