We received a letter, from Clean Air Company, which included a Certified Payroll for the installation of the Vehicle Exhaust Removal System at the Route 33 Fire Station. We received a Certificate of Liability Insurance for J. Ford Electric, the vendor used to install and repair our OPTICOM System.

Chief's Report

- 5) Two smooth bore nozzles for high rise pacs.

- 6) Ten Minitor V pagers from ESS for \$4,050.00.
- 7) Six SCBA masks from Firefighter's Equipment Company for \$1,432.08.
- 8) Five portable chargers, including installation, from A. R. Communications for \$1,935.00.
- 9) One assortment of tools for the New Engine from Snap-on for around \$1,300.00
