Communications

We received several e-mails from the State Division of Pensions, which will be on file. We also received several e-mails from the State GovConnect, which will be on file. We received two service reports, from EMR Power System, for service checks performed on our two emergency generators. These service checks were completed on August 28, 2014. We received two copies of the Fire Hose Test Results from Fail Safe Testing. The hose testing was completed on the 1st and 8th of August, 2014. We received a letter, from Glatfelter Claims Management, stating that our claim for the damage to the front bumper area on 19-2-78 has been approved. Enclosed with the letter was a check for the repairs, less \$500.00 deductible. The check, in the amount of \$3,109.63, was received and deposited on August 7, 2014.

We received an Affidavit of Publication, from the Asbury Park Press, for the advertising of our Notice to Bidders for the new Chief's Command Vehicle. We received a check, from VALIC, which are returned LOSAP funds from a Firefighter who left the Company before being vested. The check, in the amount of \$1,768.39, was received and deposited on August 8, 2014. We

received a check from a local neighbor for the purchase of our old Landpride three point hitch mower. This mower was declared as surplus equipment and was no longer needed. The check, in the amount of \$100.00, was received and deposited on August 21, 2014. We received the minutes from the June 7, 2014 New Jersey State Association of Fire Districts meeting. The next meeting will be held on September 12, 2014 at the Wildwood Convention Center.

Legal

There was no legal report due to the absence of Mr. Youssouf.

Chief's Report

Chief Bob Tice gave his incident report for the month of August, 2014. Chief Tice said that we had one Major Structure Fire on August 20, 2014 and had two injuries. One injury was minor and one Firefighter was transported to the Hospital by Ambulance. This Firefighter was later released with no major injuries. The Chief would like to purchase the following items.

- 1) Three (3) 100 foot lengths of 3" Rubber Hose from Continental Fire and Safety for a total of \$1,193.40.
- 2) Four (4) 25 foot lengths of 3" Rubber Hose from Continental Fire and Safety for a total of \$604.40.
- 3) Five (5) 50 foot lengths of 2.5" Woven Hose from Continental Fire and Safety for a total of \$748.75.
- 4) Shipping charge for all hose to our location of \$100.00.
- 5) Live Fire Training at the Middlesex Fire Academy for an amount to be determined by the number of Firefighters.

After some discussion, a resolution was offered by George Patten and seconded by Doug Howlett, granting the Chief's purchase requests. A roll call vote was taken.

Chief Tice also said that they are rethinking the Junior Firefighter By-Laws. As of now 16 and 17 year old Junior Firefighter's are permitted to ride on the first due Fire Apparatus. Junior Firefighter's are not trained in the use of SCBA's and are not allowed to wear SCBA's. Sometimes the first due Fire Apparatus is located in an area which would require the use of an SCBA. This subject will be brought back to the October 6, 2014 meeting when Mr. Youssouf will be present.

Committees

Frank gave a report on the Executive Board Meeting which was held on August 28, 2014. Frank also gave a report on the trucks as follows.

- 1) The annual Ground Ladder and Aerial tests are scheduled for September 11, 2014.
- 2) The Battery Charger on 19-2-75 was replaced by Campbell Supply.

- 3) The old Battery Charger was sent out for repairs by Campbell Supply and will be used as a spare when it comes back.
- 4) The annual Hose Testing was completed on August 8, 2014.
- 5) The annual pump tests are scheduled for September 17, 2014.
- 6) 19-2-68's vehicle was repaired at Pine Belt. They replaced the left temperature door actuator.
- 7) 19-2-66's vehicle was repaired at Pine Belt. The replaced a bad air bag sensor.
- 8) Frank purchased new front brake pads and rotors for 19-2-68's vehicle. They will be installed in the next week.

Old Business

Frank read over the Bid Results from the Bid Opening on Thursday, August 21, 2014 at 2:00 PM. Present at the Bid Opening were Harry Carter, George Patten, Frank Biddle III and Joseph Youssouf. At 2:00 PM Mr. Youssouf brought the meeting to order and said that we had received two bids.

- 1) Mall Chevrolet, 2015 Chevrolet Suburban as specified \$43,650.00, with optional 30 additional months of OnStar, \$649.00 and optional trade-in of 2003 Suburban -\$3,500.00 for a total of \$40,799.00.
- 2) Hertrich Fleet Services, 2015 Chevrolet Suburban as specified \$39,778.00, with optional 30 additional months of OnStar Safe & Sounds with Directions and Connections, \$1,078.00 and optional trade-in of 2003 Suburban -\$2,300.00 for a total of \$38,556.00.

After some discussion, a resolution was offered by George Patten and seconded by Doug Howlett, to purchase the New Chief's Command Vehicle from Hertrich Fleet Services with options and the trade-in of the 2003 Suburban for a total of \$38,556.00. A roll call vote was taken.

- 3) Conversion Package from East Coast Emergency Lighting for a total of \$14,356.74.
