The commissioners have carefully considered the 2026 budget for the Howell Township Fire District #2. The overall budget is up by \$529,684 due to increases in Capital Appropriations and Debt Service. The district is utilizing \$493,480 in surplus and \$250,000 in Capital Outlay to offset this increase. It should be noted that the district has not had a debt service appropriation in many years.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item. Be sure to include ALL items for F-2, F-3, and the detail sheets.

Capital appropriation is up 31.1% due to increased capital needs which can vary from year to year. Capital Reserve appropriation is up 10% due to needing to replenish future reserves. Debt Service is up 100% as this is new and the district has not had Debt Service needs in many years. Advertising is up 10% due to increased publishing costs, hydrant rentals are up due to rate increases by the service provider, and stipend program is up to help attract more volunteers.

The district tax levy will increase by \$294,900. Capital needs and the debt service appropriation account for a majority of the increase.

No the district will not exceed the cap levy in 2026.

\$250,000 from reserve for future capital outlays will be utilized to offset the \$250,000 of capital appropriations.

The district has budgeted \$529,084 for debt service which is funding a new fire vehicle. The district is also budgeting \$484,000 for reserve for future capital outlays to replenish the reserve for future years capital needs.
